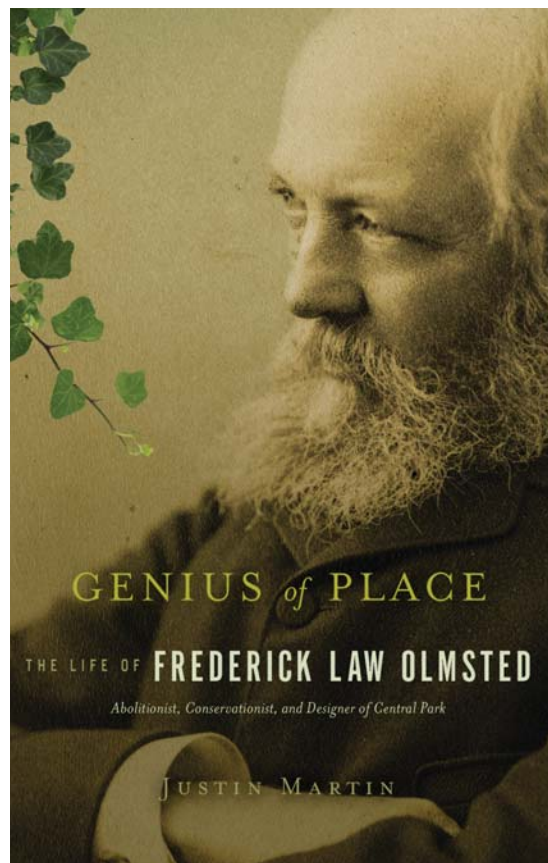

The meeting agenda includes a summary of activities and accomplishments for 2011, and the nomination of FLOS 2012 Officers and Board of Directors. A highlight of the evening will be a lecture by Olmsted biographer Justin Martin.

Mr. Martin is the author of three biographies, most recently *Genius of Place: The Life of Frederick Law Olmsted*. Justin Martin will also conduct a book signing at the Riverside Library on Saturday, January 14, 2012, at 1:00 pm in the Great Room in front of the fireplace.

Meet FRED!

FRED is coming to Riverside! The Frederick Law Olmsted Riverside Education and Design Weekend (FRED) will be held August 16 through August 18, 2012. Sponsored by FLOS, the FRED is a three-day education and networking event that celebrates and provides education on garden and landscape design in Riverside, Illinois.

“FRED is the perfect match for Riverside,” says Cathy Maloney, one of FRED’s organizers and a FLOS Board member. “How appropriate for our community to host an event that highlights landscape design.” Using the Riverside “campus,” the FRED will include professional and public educational seminars, walking tours and design competitions, and hands-on demonstrations to explore the world of landscape architecture from the days of Riverside’s design master, Frederick Law Olmsted to today’s newest trends.

Partnerships with the Illinois chapter of the American Society of Landscape Architects (IL-ASLA), the Illinois Landscape Contractors Association (ILCA) and other local and regional groups are underway. The ILCA plans to host its professional education seminar during the first two days of the event with classroom instruction and tours of Riverside. The last day of the weekend will be open to the public.

“We think the FRED will draw lots of interest,” says Kim Jacobs, FLOS President. “Home gardeners, landscape professionals, historians and nature lovers will find lots to see and do at FRED.”

The Nominating Committee was made up of Chairperson Rachael Franceschina, Board members Cindy Kellogg and Harjit Singh, and members at large Kristin Peschke, and Dorothy Sikora. The nominees will be presented and voted on at the annual meeting.

Landscape Committee 2011 Recap

The Landscape Committee had a phenomenal year. In conjunction with Chicago Wilderness, we hosted an expert round table in May to discuss riverbank restoration as it pertains to Riverside. In September, three committee members and four village employees attended prescribed burn training at the Morton Arboretum. Both events provided our committee with enough information to confidently lead four very successful landscape workdays on our riverbank. We cleared buckthorn along the Des Plaines River on Riverside Road from Gage to Olmsted Roads. The view of the river on that stretch is amazing! We've ordered the propagation of 16 flats of native sedges and grasses to be planted in 2012 and also plan to conduct prescribed burns to the area. Prescribed burns are a proven and cost-effective technique to remove weeds and promote the growth of native plants.

In addition to the riverbank, we worked four days each on the Longcommon and Scottswood Common. **A whopping 618 total volunteer hours were logged during twelve scheduled landscape workdays in 2011!** We are so fortunate to have such dedicated volunteers who also make workdays fun. We'd like to thank the regulars: Tom G., Bob F., Ken P., Eric Z., Dorie S. & family, Tim O. & family, Ken & Nick S., Fred K., Shaun S., Kim J. & family, Carolyn H., Jim B., and Harjit S. We'd also like to thank Hauser Middle School teachers, Lynn Janik and Kelly Schuldt, for organizing the student council to attend the April 9th workday at the Big Ball Park. They came out in force! We'd like to thank the leaders of Boy Scout Troop 24 for encouraging their scouts to obtain service hours by attending our landscape workdays. We also must thank Mike Collins, Riverside Forester, for his years of dedication to our committee and projects and Ed Bailey, Public Works Director, for his unwavering support since his arrival to Riverside. We thank you all from the bottom of our hearts!
